## OFFICIAL RULES Duck Tape® Maker $^{\rm TM}$ 2018 Giveaway Sweepstakes

**General Entry Conditions.** Multiple participants may not use the same Instagram or Twitter account. All of the foregoing content requirements and prohibitions are herein referred to as the "Content Restrictions". The Winner(s) must follow instructions given by Sponsor or designated agent, including, but not limited to, responding to notification with requested information, within seven (7) days of receiving notification.
